### From the Sergeant – Danielle Bristow

This month has been a busy month with the team taking part in various operations across the district. A new campaign has been launched in partnership with Warwick and Stratford District Council to raise awareness of 'county lines' serious and organised crime within South Warwickshire. County Lines is the term used to describe a criminal business model were gangs or criminal networks move drugs into local areas using a dedicated mobile phone lines to take orders. County Lines gangs often exploit children and vulnerable adults by forcing them to carry out criminal activity by threats, grooming and extortion. The gangs will also take over the home of a vulnerable person where they set up a base.

Would you know the signs? This could be changes in someone's behaviour or wellbeing i.e. making unusual purchases or transactions, socialising with unfamiliar people, having access to money they can't account for. They might be buying expensive goods they may not be able to afford or having multiple phones, tablets or SIM cards. Are you a landlord or do you share a house - Is a tenant getting more visitors? Do visitors come at unusual times of the day or night or are the curtains or blinds almost always shut?

Welcome to the December Warwick Rural West newsletter.

With the new tier system in place we are all going through tough times, whether it's struggling with mental health or worrying about how this will affect the festive period. Diwali celebrations took place for 5 days in November and had to be conducted in a different way this year, I hope this was still enjoyable.

The team and I have been working hard this month to keeps our community's safe with proactive targeted patrols around local parks to try and combat the use of cannabis. Stop searches have been conducted and drugs paraphernalia seized.

As part of Op Sceptre, a bi annual national knife crime campaign, we conducted knife sweeps of parks reassuringly with negative results, which is pleasing. A male was stopped and searched and was found to be in possession of a small hatchet style weapon so was arrested and dealt with.

Road Safety week was also this month and we have been conducting speed checks and assessing other safe speed check spots in rural surroundings. Parking has become an issue around the countryside with vehicles parking at the side of lanes to go for walks, we are monitoring this issue.

Please be assured that we are still dealing with the ASB, COVID19 related breaches and neighbourhood disputes. We continue to work with other agencies, adapting the way we do this – so mainly via email and phone, to keep you all safe.

### This month's CRIME PREVENTION ADVICE...

Has your child asked for an E scooter for Christmas.....Please read, this may change your mind!!

Buying an e-scooter can be tempting, especially as you can get them from many popular retailers. However the law is clear. You can buy one but it is illegal to use a privately owned e-scooter in any public space including roads, pavements, parks, town centres or canal towpaths for example. The only place a privately owned e-scooter can be used is on private land."

E-scooters are classified as Personal Light Electric Vehicles (PLEVs) so they are treated as motor vehicles and subject to the same legal requirements such as MOT, licensing, tax and insurance.

Whilst some parts of the country are taking part in Government trials for e-scooter hire with a view to making them legal to use on the roads, Warwickshire is not currently part of the trials so e-scooters cannot be hired at this time.

Warwickshire Police have the powers to seize e-scooters and prosecute riders— please make sure you keep your e-scooter on private land so this doesn't happen to you.

Officers will also be using Section 59 of the Police Reform Act to issue a warning to riders of e-scooters and educate them as to the legal requirements. If a rider is under 16 years old then this advice will also be given to the parents
